Description of the research project/topic	The objective of BePART is to understand if and how the digital transformation of organizational structures, processes and performance measurement and management systems in the co-production of public services restores citizens' trust in PAs. BePART will adopt an inductive-deductive methodology divided into the following four phases: review of the literature on the project themes to systematize existing knowledge; ex-ante case studies in Italian local administrations to generate a conceptual basis for the research; survey administered to a sample of Italian local administrations to test the hypotheses emerging from the previous phases; ex-post confirmatory case studies to triangulate the data and analyze them in an explanatory perspective functional to formulate political and management recommendations.
Activities entrusted to the research fellow (ITA)	L'assegnista parteciperà alle attività rientranti nelle fasi 2, 4 e 6 del progetto di ricerca. In particolare, relativamente alle fasi 2 ("Ex-ante Case Study") e 4 ("Ex-post Case Study"), l'assegnista parteciperà alla conduzione dei case study attraverso la raccolta dei dati attraverso fonti documentali e orali, all'analisi e interpretazione di questi, oltre che alla predisposizione del report sulle attività delle due fasi. Relativamente alla fase 6 ("Dissemination"), l'assegnista contribuirà alle attività di disseminazione dei risultati del progetto nelle unità di ricerca coinvolte nelle fasi 2 e 4, alle attività di disseminazione al pubblico dei risultati del progetto (attraverso la realizzazione di contributi scientifici e loro presentazione in occasione di convegni, seminari scientifici e convegno finale di progetto), oltre che alla predisposizione del report finale di progetto.

Activities entrusted to the research fellow (ENG)	The grant holder will participate in the activities included in phases 2, 4 and 6 of the research project. As for phases 2 ("Ex-ante Case Study") and 4 ("Ex-post Case Study"), the grant holder will participate in the conduct of the case studies by collecting data from primary and secondary sources, analysing and interpreting such data, as well as by preparing the final report of both phases. Regarding phase 6 ("Dissemination"), the grant holder will contribute to the dissemination of the project activities and results both to the research units involved in phases 2 and 4 and to the public. The preparation of the "Be-PART Report", the participation as co-author to scientific publications related to the project results and their presentation at national and international conferences are among the activities of dissemination the grant holder will be involved in.
