### NOTICE SOLIDARITY FUND 2022

#### Art. 1 - Subject and scope

1. The fund is made available to University of Siena students coping with difficult personal or family circumstances, even if temporary, or with an immediate and substantial change to their personal and/or family finances.
2. Support consists in the total or partial exemption from payment of university fees and dues or of any late payment fees, except for the regional DSU tax and the virtual stamp duty required by the laws in force.
3. Total or partial exemption refers to the payment of fees for academic year 2021-2022 and any outstanding fees up to and including academic year 2016-2017.

#### Art. 2 – Recipients

1. University of Siena students enrolled in first cycle, long single cycle or second cycle degree courses may apply.
2. Cases in which one may submit an application include, **but are not limited to**, the following:
  - a. illness, personal or that of a parent or a member of the family unit;
  - b. serious accident or surgery, personal or to a parent or a member of the family unit;
  - c. death of a member of the family unit or of a non-cohabiting sibling;
  - d. redundancy/unemployment/temporary redundancy of a parent or another member of the family unit;
  - e. economic activity of a parent or another member of the family unit suspended due to the Covid-19 health emergency
  - f. difficult economic situation of the family (due to divorce, separation, ecc)
  - g. loss of the home of residence due to a judiciary proceeding for the forced recovery of credit;
  - h. area of residence affected by seismic events and/or natural disasters, provided that the resident home has been declared unfit for occupancy;
  - i. 50% - 65% disability, as established by article 21, paragraph 2 of the Regulations for the calculation and payment of fees and dues for enrolment on courses at the University of Siena - academic year 2021/2022.

#### Art. 3 - Application procedure and deadlines

1. The deadline for submitting an application is **Wednesday 11 May 2022 at 12 noon**.
2. Applications may be submitted from **12 noon on Thursday 21 April 2022 until 12 noon on Wednesday 11 May 2022** by accessing the dedicated area of the *Segreteria on-line* platform (<https://segreteriaonline.unisi.it>) - *Incentivi premi di studio borse*; applications sent by other means shall be rejected
3. The following files must be attached to the application:
  - a) **the Application form (annex 2), duly completed and signed (scanned copy or image file)**
  - b) **documentation attesting to the grave personal, family or financial difficulties (documentation must be submitted as a single file)**

4. To confirm application submission, you must **“print out the final receipt” (confirming submission of your application)** WITHOUT THIS PRINTOUT CANDIDATES ARE EXCLUDED FROM THE COMPETITION; do not send or deliver the receipt to the *Ufficio borse e incentivi allo studio*.
5. Should the final printout be incomplete (for technical reasons due to the information system), the **date of the email receipt the candidate receives automatically** once the submission procedure is completed shall serve as proof of delivery.

**Art. 4 – Committee and assessment of applications**

1. Applications will be assessed by a special Committee chaired by the Rector's delegate to students and comprising the student members of the University Council, the Head of the *Divisione orientamento, sostegno allo studio e career service*, with the head of the *Ufficio borse e incentivi allo studio* acting as minute taker.
2. The Committee may also include the Rector's Delegate to University Access to Disabled Students should students under art. 2 par. 2 letter h submit an application.
3. The fund is for extraordinary, non-recurring circumstances: the Committee may therefore decide to not grant the fund if the student already received it previously.
4. The Committee may decide to not grant the fund if the student received other benefits from the University, other public or private bodies during the same academic year.
5. The Committee may decide to not grant the fund if the student already holds a university degree of the same level.
6. The Committee shall also take into account grades and the actual need for assistance in relation to the possibility of completing studies.
7. The Committee takes into account any disabilities recognised during the course of the academic year, even if the percentage is lower than that specified in article 21, paragraph 2 of the Regulations for the determination and payment of fees and dues for enrolment in courses at the University of Siena - academic year 2021/2022.
8. The Committee may request any other element of use in the evaluation process.

**Art. 5 - Processing and protection of personal data. Notice pursuant to art. 13 of the GDPR**

1. The University of Siena processes personal data exclusively for institutional purposes and for managing this notice. The University undertakes to respect the confidential nature of the data and information provided by the applicant, which will be processed in accordance with EU Regulation 679/2016 on the protection of personal data and Legislative Decree no. 196/2013 Privacy Code, for provisions that are not incompatible with the Regulations.
2. The Applicant may assert his/her rights (articles 15 et seq. of the EU Regulation) by contacting the Data Controller; send a message to the certified email address [rettore@pec.unisipec.it](mailto:rettore@pec.unisipec.it), or the e-mail address [segreteria.rettore@unisi.it](mailto:segreteria.rettore@unisi.it);

4. By signing the application (annex 2 to this call for applications), the student authorizes the University of Siena to use his/her address, phone or email contact, as indicated in said form.
5. Data provision is mandatory, and refusal will lead to exclusion of the Solidarity Fund 2022 application.
