Selection modalities	Evaluation of qualifications Interview
Admission requirements	All masters’ degrees (<i>lauree magistrali, specialistiche, a ciclo unico e vecchio ordinamento</i>)
Exam procedures	<p>The minimum score for eligibility is 60/100.</p> <p>Evaluation of qualifications: Minimum score 30, maximum score 50 (of which up to 30 points for the thesis).</p> <p>Oral interview: Candidates who obtain a minimum score of 30/50 in the evaluation of qualifications are admitted to the interview. Maximum score for the interview is 50; minimum score is 30. Upon request and on the basis of the decision by the selection committee, the interview can be carried out by video-conference. The interview consists in the discussion of the research project presented and the verification of the knowledge of at least one foreign language.</p> <p>The results of each test will be published on the PhD web site and communicated to the candidates by the selection committee.</p>
