

Scope of Jean Monnet actions: European Integration Matters

European Union studies refer to **the study of Europe in teaching, learning and research about the European Union**, its entirety, its history, aims structures, functions and/or its policies.



Scope of Jean Monnet actions

• EU Dimension Focus

Jean Monnet activities should promote active European citizenship and the founding values of the European Union of respect for human dignity, freedom, democracy, equality, the rule of law and respect for human rights, including the rights of persons belonging to minorities (Article 2 of the Treaty on European Union).

• EU Policy Focus

Jean Monnet actions should contribute to spreading knowledge about how these policies can benefit the daily lives of citizens in the EU and/or abroad, and/or how these can influence the policymaking system, in similar fields, either at the Member State level or abroad at a national, regional or global level. A link should be displayed between the subject of the proposal and the relevant EU policy or topic(s).

Public Diplomacy Focus

Jean Monnet actions also strive to function as a vector of public diplomacy towards third countries. They should promote EU values and enhance the visibility of what the European Union stands for and what it intends to achieve.





1. Jean Monnet actions in the field of higher education - Aims

- **Promoting excellence** in teaching and research in EU studies worldwide
- Generating knowledge and insights; supporting EU policy-making, while strengthening the role of the EU within Europe and the world
- Reaching new people; going beyond academia and specialised audiences, bringing EU knowledge closer to society in the process
- **Fostering dialogue** between academia and society, policymakers, civil servants, civil society, representatives of different levels of education, and the media
- Functioning as a vector for public diplomacy towards partner/third countries, promoting EU values while enhancing the visibility of its goals and achievements



Who can apply for Jean Monnet actions?

Higher Education Institutions

Other fields of education and training

- Modules
- Chairs
- Centres of Excellence (COE)

Any higher education institution in the world can apply. The exceptions are higher education institutions from Belarus and the Russian Federation, which cannot apply.

- Teacher Training
- Learning EU Initiatives

ONLY institutions from EU Member States or third countries associated to the Erasmus+ Programme can apply.



Expected impact – Quantitative indicators

- Number of Higher Education institutions enhancing the European Union dimension of the disciplines they cover.
- Number of European Union topics introduced in the teaching and research of Faculties/Departments where the EU angle is not usually developed beyond the subjects typically known for their EU association.
- Number of students reached by the Jean Monnet actions.
- Number of new Chair Holders.
- Number of publications on EU-related topics.
- Number of policy papers to support policy makers on EU-related topics.
- Number of Jean Monnet projects in third countries not associated to the programme



Expected impact – Qualitative indicators

- Increased knowledge on European policies.
- Extent to which Higher Education Institutions engage with the wider society and the non –academic world, on EU topics.
- Increased awareness on EU-related issues in the non-academic world.
- Improved dissemination of Jean Monnet projects results across society, including policy makers.
- Extent to which fora and platforms aiming at improving the cooperation and dialogue between the academic and nonacademic world are in place.
- Increased opportunities for young researchers to enhance their professional competences and boost their career.

2. Jean Monnet actions in other fields of education and training - Aims

Funding Opportunity

- Teacher Training: 300,000 EUR maximum
- Learning EU Initiatives: 30,000 EUR maximum
- **Promoting active citizenship and common values;** learning about the objectives and functioning of the EU, promoting active citizenship and common values of freedom, tolerance and non-discrimination.
- Enhancing the professional development of teachers and trainers by introducing the European dimension of teaching at school.
- **Promoting EU literacy**; fostering a better understanding of the EU and the functioning of its institutions, addressing the lack of knowledge about the EU while tackling disinformation.





2. Who can apply for Jean Monnet actions in other fields of education and training?

Teacher Training

- Higher education Institutions providing initial and/or in-service training to teachers of schools and/or VET institutions (ISCED 1 - 4) and holding a valid ECHE; OR
- **Teacher training institutions** or agencies providing initial and/or in- service training to teachers of schools and/or VET institutions (ISCED 1 4).

The applicant must be established in a Member State of the EU or a country outside of the EU associated with the Erasmus+ Programme.

Learning EU Initiatives

 Any school or vocational education and training institution (VET) (ISCED 1 – 4).

The applicant must be established in a Member State of the EU or a country outside of the EU associated with the Erasmus+ Programme.

3. Jean Monnet Policy Debate

Large thematic networks in Higher Education in order to collect, share and discuss among the partners research findings, content of courses and experiences, products (studies, articles, etc.). A) Network on internal EU issues on the thematic: "An economy that works for people"

• Eligibility

EU Member States or third countries associated with the Erasmus+ Programme.

Composition

A minimum consortium of at least 12 higher education institutions from applicants, consisting of at least 7 different EU Member States and/or third countries associated with the Erasmus+ Programme. Only beneficiaries (not affiliated entities) count for the consortium composition.

B) Network on external policy issues on the thematic: "EU-Latin America"

• Eligibility

- A HEI established in the EU Member States and third Country Associated with the Erasmus+ Programme
- A HEI established or in the following third countries not associated to the Erasmus+ Programme: Latin America countries (region 10)

- Organisations from Belarus and the Russian Federation are not eligible to participate.



Maximum EU Contribution:

Composition

Proposals must be submitted by a consortium of at least 12 applicants which complies with the following conditions:

- Minimum 5 entities from 5 different countries in Region Latin America (region 10);
- The coordinator has to be established in a EU Member States or a third country associated with the Erasmus+ Programme.
- Only beneficiaries (not affiliated entities) count for the consortium composition.

C) Network on external policy issues on the thematic: "EU-Africa"

Eligibility

- A HEI established in EU Member States and third country associated with the Erasmus+ Programme

- A HEI established in the following third countries not associated to the Erasmus+ Programme: Sub Saharan Africa countries (region 9); Algeria, Egypt, Libya, Morocco, Tunisia (Region 3) may also participate but not as coordinator

Composition

Proposals must be submitted by a consortium of at least 10 applicants which complies with the following conditions:

- Minimum 5 entities from 5 different countries in Region Sub Saharan Africa (region 9);
- The coordinator has to be established in a EU Member State or Third Country Associated with the Erasmus+ Programme.
- Only beneficiaries (not affiliated entities) count for the consortium composition.



Maximum EU Contribution:

1,200,000 EUR





D) Networks in other fields of Education and Training

Activities facilitating a common understanding on learning methodologies about European Union matters among practitioners working in different contexts, facing different challenges and constraints due the national legislations and the structure of the curricula.

 Who can apply? EU Member States or third countries associated with the Erasmus+ Programme

• Aims

- Offer support to schools & VETs, (ISCED 1 4), and/or higher education Institutions involved in Teacher Training /Education for boosting knowledge on how to teach European Union subjects;
- Exchange of knowledge, collaborative working on specific subjects and on methodologies, co-teaching experiences;
- Enhancing cooperation between different schools/VETs (ISCED 1 4), teacher training/education providers; creating a solid and sustainable knowledge platform.

Maximum EU Contribution: 300,000 EUR



Jean Monnet Actions - Award Criteria (2021-2027)

Although there are slight differences between Jean Monnet actions, to be considered for funding proposals must score at least 70/100 points in total and 15/25 points in each award criterion. There are four award criteria and each is worth a maximum of 25 points.

Tips for Applications

Be coherent!

Avoid contradictions and "cut and paste" style applications

• Be concrete!

Use examples, justify your claims, provide evidence.

Remain focused!

Concentrate exclusively on what is asked of you.

• Be explicit!

Take nothing for granted and don't assume that experts have prior knowledge in your area. Avoid abbreviations or explain them.

• Be realistic!

The application is the basis of your project to be; it is also the cornerstone of the commitment you will sign.

Double-check your proposal!

Make sure you have followed all instructions and the proposal meets all mandatory requirements.

• Be clear!

Read the questions carefully, provide information in the correct order as indicated in the form.

• Keep it simple!

Use short sentences, vary the length if you wish to make it more interesting but keep it simple and focused.
