 - Italian degree (*Laurea*) awarded according to the university rules prior to Ministerial Decree no. 509/99 (lasting at least 4 years)
 - Italian second cycle degree (*Laurea Specialistica/Magistrale*) lasting 3+2 years or a single 5-year cycle)
 - Academic qualification (degree) gained abroad, equivalent to an Italian qualification in length and content.

Applicants must be in possession of the admission requirements or gain their degree before 31 October 2013.

Academic qualifications obtained abroad

Academic qualifications obtained abroad, following courses lasting at least four years, must be recognized as second cycle degrees and permit admission to doctoral programmes in the country in which they were awarded.

Candidates with foreign academic qualifications must enclose with their printed or online application:

- a transcript in Italian or English (or translated into Italian or English). Those who have not yet been awarded their degree must provide a list of exams taken and grades awarded, translated into Italian or English;
- a copy of any documents of use to evaluate the recognisability of the qualification (e.g. diploma supplement, course contents, declaration of value).

Candidates with foreign academic qualifications will be admitted to the selection procedure conditionally and will be excluded from the Doctoral Research Programme if, following verification, their qualification is found not to comply with the requirements specified in the call. If successful, candidates must provide the documents specified in art. 5.

16. **Application procedure**

Applications must be made using the online procedure described on the following page <http://www.unisi.it/ricerca/dottorati-di-ricerca> clicking on the Doctoral Programme of interest **by the final deadline of 13:00 on 25 November 2013**

E-mail confirmation of successful registration of the application is sent automatically to the address indicated by the candidate in the application form.

Should it not be possible to use the online application procedure, applications can also be presented in one of the following ways:

□ by post, using recorded delivery with return receipt, to: Divisione Corsi di III Livello – Dottorato, Collegio Santa Chiara, Via Valdimontone 1, 53100 Siena. Candidates residing abroad can use any form of postage that provides legible proof of the date of dispatch.

In any case, applications and documents must be received by the University of Siena by the final deadline 13:00 on 25 November 2013. Only the date of receipt, not the date of postage, will be considered.

For applications made either online or in printed form, candidates must provide the “documents of use for evaluation”, as specified in the table (art. 1 of the doctoral programme call), by the call deadline.

In the case of online applications the abovementioned documents must be sent with the application, in electronic form. If the candidate making an online application is unable to send the abovementioned documents in electronic form, the documents must be delivered or sent in printed form according to the instructions and deadline specified above for the delivery/postage of printed applications. The abovementioned documents must be enclosed in a sealed envelope and the **slip containing the application details** received in the e-mail confirming registration of the application must be attached to the envelope.

Documents other than those stated herein as useful for evaluation and documents that arrive after the abovementioned final deadline of **25 November 2013** will not be taken into consideration.

In the case of applications presented in printed form, the abovementioned “documents of use for evaluation” must be delivered or posted in printed form according to the instructions and deadline specified above for the delivery/postage of printed applications.

Candidates must choose only one of the Research tracks possible within the Doctoral Programme they are applying for.

The University can, by reasoned decision, exclude candidates from the selection procedure at any time if they lack the admission requirements specified in this call.

17. **Documents for evaluation**

The documents required for the purpose of evaluation are:

Curriculum vitae;

Letter of presentation from a University professor;

Project regarding the research track chosen, either: 1) “People and markets in juridical experience”; 2) “History, theory and comparison of legal systems.”

These documents must be sent in electronic format with the online application. If the candidate is unable to send the documents in electronic format, they must be sent in printed form and in any case accompany the candidate’s online or printed application.

18. **Exam details**

Candidates must indicate in their application which research track they intend to select from those available on their PhD programme (“People and markets in juridical experience” or “History, theory and comparison of legal systems”).

The admission exams take place as follows: candidates sit a written exam, which consists of an essay providing a systematic account of the debate on an assigned topic (relating to the chosen research track) and highlighting, where applicable, the different positions held in the doctrine and jurisprudence and the reasons for preferring one or another. The written exam will take place at the Circolo Giuridico (Law Library, in via Mattioli 10), where books and journals will be available, or in a room equipped with computers with access to the University databases and to journals available online; the computers will be assigned to candidates individually so that each candidate’s research activities can subsequently be monitored.

Candidates who pass the written exam will be required to take an oral exam, during which their knowledge of legal English will also be tested.

19. **Exam schedule**

The dates of the written and oral exams will be available on the following website: <http://www.unisi.it/ricerca/dottorati-di-ricerca> (clicking on the relevant doctoral programme) at least 15 days before the exams take place. No written notice will be issued concerning the exam schedule.

20. **Enrolment of successful candidates and Documents required for enrolment**

There will be a single final ranking list, published on the following page: <http://www.unisi.it/ricerca/dottorati-di-ricerca> clicking on the Doctoral Programme of interest.

Successful candidates will not be notified in person.

Places may be reserved for graduates of foreign universities, foreign grant recipients, those participating in specific international mobility programmes, or recipients of research grants in the same scientific-disciplinary area as the research programme, depending on their place in the ranking list, and as long as the study or research grant has the same duration as the Doctoral Research programme (at least 3 years).

The simultaneous enrolment on a first or second cycle degree, postgraduate specialization course (except for medical specializations) or another Doctoral Programme is not permitted.

Doctoral students may attend medical specialization courses at the same time as the Doctoral Programme. In this case, the duration of the Doctoral Programme is reduced to a minimum of two years (art. 19, Law 240/2010).

Without receiving further notice from the University, successful candidates must send the forms listed at <http://www.unisi.it/ricerca/dottorati-di-ricerca> clicking on the Doctoral Programme of interest **by the final deadline of 20/12/2013** to: Divisione Corsi di III livello – Dottorato, Collegio S.Chiera, Via Valdimontone 1, 53100 Siena (opening hours: Mon/Wed/Fri. 9.00-13.00; Tues/Thurs 14.30 -16.30) (Failure to do so will result in exclusion):

- enrolment form bearing a revenue stamp for €16 Euros;
- study grant acceptance form (if applicable);
- request for canteen access card;
- request for a university e-mail address;
- signed photocopy of identity card/passport;
- copy of receipt for payment of regional tax (*Tassa Regionale per il Diritto allo Studio Universitario*);
- copy of receipt for payment of university fees;
- copy of visa in passport and residence permit (only for non-EU students).

Candidates who are admitted and hold a **foreign degree** (conferred at the end of a degree course lasting at least 4 years) which has not yet been recognized by an Italian University as equivalent to one of the Italian degrees required, must submit the following documents together with the enrolment form:

- photocopy of their original diploma and degree certificate with list of exams and grades, translated into Italian and legalized by the competent Italian authorities abroad (Italian Consulate or Embassy);

- **Declaration of Value “in loco”**, clearly stating that the academic qualification possessed gives access to Doctoral Research Programmes in the country in which it was awarded.

Candidates with foreign academic qualifications who cannot deliver the documents required at the time of enrolment will be enrolled conditionally and will be excluded from the Doctoral Programme if they fail to present said documents by the deadline set by the Administration. They will also be excluded if their qualifications are found not to comply with the requirements specified in the call.

Non-EU candidates who have passed the admission exam will be admitted to the courses as long as they have a permit to enter and reside in Italy and are legally residing in Italy (art. 39, par. 5, Legislative Decree. 25.07.1998 no. 286 as modified by art. 26 Law 30.07.2002 no. 189); they must present a copy of their passport and a valid residence permit issued by the competent authorities along with the enrolment form.

Non-EU citizens residing abroad must present a copy of their passport, entrance visa and residence permit for the purpose of study issued by the competent *Questura* (Police headquarters).

Successful candidates who do not complete the enrolment procedure by the deadline will be considered to have renounced their place.

Vacancies may be made available to the next candidates in the ranking list.

University fees

The annual enrolment fee is 300.00 (three hundred) Euros, to be paid at the time of enrolment. Payment can be made:

Regional tax

Annual payment of a Regional Tax for the Right to University Study is required by Regional Law no. 4 of 3 January 2005. For the academic year the tax is 140.00 (one hundred and forty) Euros and can be paid as follows:

Exemption from payment of taxes and fees

Students with certified disability equivalent to 66% or higher, are exempt from the payment of any taxes or fees.

Recipients of a research grant for the Doctoral Programme financed with funds from the Ministry for Education, University and Research (MIUR) are exempt from payment of university enrolment fees.

Research grants

Research grants are awarded on the basis of the ranking list formed following the admission exam.

The gross annual amount of the research grant is 13,638.47 Euros.

As long as the student is authorized by the Academic Board to carry out research abroad, the amount of the grant is increased by up to 50% for a maximum of 18 months during the period abroad.

The grant will be paid for the whole duration of the course.

Payments are normally made in monthly instalments in arrears.
